MINUTES OF THE FREEHOLD BOROUGH HOUSING AUTHORITY June 1, 2022 at 5:00 p.m. – Regular Meeting

Executive Director Joseph M. Billy, Jr. called the meeting to order at 5:00 p.m. in the Administrative Office of the Freehold Borough Housing Authority. The following Commissioners were present: Commissioner William Cannon, Commissioner Ruthann Broxmeyer, Commissioner Susan Sweetman, and Commissioner Meg Thomann. Also, present were Executive Director Joseph M. Billy, Sharon Whetzler, and Attorney Nicole Crismale.

Executive Director Joseph M. THE MINUTES OF THE May 4, 2022 MEETING: Commissioner Thomann motioned and seconded by Commissioner Sweetman to approve the Minutes. The roll call was unanimous and the minutes were approved.

ATTORNEY REPORT: Ms. Crismale reported to the Board that the personal injury litigation has been scheduled for mediation on June 9, 2022.

REPORT OF THE EXECUTIVE DIRECTOR:

At this time, Mr. Billy, Executive Director reported on the following topics:

Mr. Billy presented to Commissioner Thomann her final Certificate of Completion from Rutgers regarding her completed training courses. Congratulations....

Mr. Billy reported the Board members have received in their monthly package an updated Treasurer report as of April 30, 2022. Mr. Billy reported that the Housing Authority received multiple funds from the Emergency Rental Assistance Payment Program, collected up to date subsidies, Capital Fund Program funding and noted that the Housing Authority finance are solid as reported in their package.

Mr. Billy reported the Board members received in their package an updated vacancy report as of April 30, 2022. The Housing Authority currently has 3 vacant unit at the senior location for which 1 unit has a move in date of June 1st and 4 vacant units at the family site, again 1 unit has been rented for June 1st and the remaining 3 are awaiting potential tenants.

Mr. Billy reported to the Board that Sebco Laundry Service is waiting their inventory of equipment regarding our new laundry smart card equipment with an anticipated delivery time of installation of 45-60 days.

<u>RESOLUTION #794-22:</u> Commissioner Sweetman motioned and seconded by Commissioner Thomann to approve the list of bills presented for payment dated June 1, 2022. The roll call was unanimous. The bills were approved for payment.
