MINUTES OF THE FREEHOLD BOROUGH HOUSING AUTHORITY January 4, 2023 at 5:00 p.m. – Regular Meeting

Executive Director Joseph M. Billy, Jr. called the meeting to order at 5:00 p.m. in the Administrative Office of the Freehold Borough Housing Authority. The following Commissioners were present: Commissioner William Cannon, Commissioner Ruthann Broxmeyer, Commissioner Susan Sweetman, Commissioner Erika Woods, and Commissioner Meg Thomann. Also, present were Executive Director Joseph M. Billy, Sharon Whetzler, and Attorney Peter C. Lucas.

Executive Director Joseph M. Mr. Billy reported the Board members received in their monthly package an updated Treasurer report as of November 30, 2022. Mr. Billy reported that the Housing Authority finances and investment continue to be in healthy conditions as reported.

Mr. Billy reported the Board members received in their package an updated vacancy report as of November 30, 2022. The Housing Authority currently has 1 vacant unit at the senior location and 3 vacant units at the family site. Sharon continues to accept applications and interview potential tenants. HUD is happy with a PIC score rate of 95% or higher. The Housing authority continues monthly meeting with HUD based on our REAC inspection/vacancies. We are not a troubled Housing Authority.

Mr. Billy reported that our Re-Organization Brunch will be held on Sunday, January 22, 2023 at 11:00 a.m. at the American Hotel, Freehold.
